## President's Message



A special thank you to David Bridges for his leadership as President of the AgFirst Retiree Association during the Covid years...I am sure he was beginning to think his term was a lifetime appointment. The Retiree Association elected and/or

confirmed the current Board at its 2023 Annual Conference in Myrtle Beach during March 2023. Your Board is well qualified and eager to serve.

The objective of today's message is to encourage each of us to plan ahead and stay engaged. A reasonable estimate of the average age of the AgFirst Retirees would be around 70 with the range being between the late-50's and the mid-90's. One of the most frequent responses heard from the younger retirees is, "I'll come to the annual meeting one of these days"! c. An update on AgFirst and the Farm Credit System by one of its senior officers;

d. Update on the Retiree Association from officers and board members including any necessary business transactions;

e.Tuesday afternoon is free time and typically includes fee-based activities, such as golf, pickleball, tennis, spa, shopping, etc.; and

f. The evening is capped off with a no-cost reception followed by a banquet meal and entertainment.

5. Most attendees check out on Wednesday morning but you will have the option to stay a few days before and after the conference at the conference room rate.

We really want and encourage you to attend and stay engaged with your fellow retirees. The cost of the tour, socials, and a couple meals are covered thanks to the generosity of the District Associations and AgFirst. You will cover your travel, room cost, and meals not associated with the conference.

Given the demographics of the retirees, we are painfully aware that we are not promised tomorrow. So, let's enjoy each other while we are able to do so. May God bless and keep you until we meet again.

### AgFirst Farm Credit Retiree Association Membership Meeting Tuesday, March 14, 2023

A meeting of the membership of the AgFirst Farm Credit Retiree Association was held on Tuesday, March 14, 2023 at the Hilton Myrtle Beach Resort in Myrtle Beach, South Carolina.

President David Bridges welcomed everyone to the meeting and called on Bill Melton to give the invocation. David asked for all veterans to stand an be recognized, followed by the pledge of allegiance. David also recognized those individuals who have assisted him this past year in making things happen.

A quorum was determined and the meeting was called to order.

*Ag Tour/Reception and Activities* — David gave an overview of yesterday's Ag Tour and thanked everyone who was involved in coordinating the tour. He also reviewed the pickleball and golf activities scheduled for this afternoon. David also noted that the reception last evening was well attended and hoped everyone enjoyed themselves.

*Welcome* - Bryant Sansbury, CEO of ArborOne Farm Credit, welcomed everyone to ArborOne territory, and shared with the group background information on ArborOne, noting that the coop model is alive and well. The association will be paying starting this month more than \$6 million in 2022 patronage. However, many challenges are ahead with farm profitability flattening out, operating costs increasing and weather concerns.

*AgFirst Bank/District/System Update* – Tim Amerson, CEO of AgFirst Farm Credit Bank—provided an update on the Farm Credit System and the AgFirst District. Financially, the System is in a very strong position. The System has approximately \$373 billion in loans; \$477 billion in assets; and net income last year of \$7.3 billion, down slightly from the previous year. There are currently 67 Farm Credit institutions, with the AgFirst District representing about 10% of the System's volume.

The AgFirst District association count as of April 1, 2023, will be 16 following three recent mergers (MidAtlantic and AgChoice, forming Horizon; Cape Fear merging with AgCarolina; and Carolina merging with AgSouth). The District had about \$762 million in net income last year, which is a little down from the previous year. The Bank's net income last year was about \$412 million. The Bank is performing in accordance with established plans and income is again expected to be good this year but lower due to rising interest rates and technology projects. New projects to be implemented this year include a new loan system replacing COAL and REAL; a new loan origination system (commercial and consumer); a new relationship management system (CRM); updating AccountAccess; and Connect First (connecting systems).

Because of these projects, the Bank's workforce has increased. Normal workforce is around 500 (400 full-time employees/100 contractors) but peaked last year at 1,200. Tim noted that this year will be extremely challenging and a miserable one for association staff with the large amount of changes being implemented. However, these new systems will put AgFirst District in a strong, solid position.

Before closing, Tim noted that the retirement is 90% funded and even though there is volatility in the market these days, the retirement fund is very stable.

*Cyber Security* - Andrew Bowden, Security Operations & Cyber Defense Manager at the AgFirst Bank, noted that as information technology becomes increasingly integrated with all aspects of our lives, cyber attacks have become more common and sophisticated. In this regard, Andrew spoke about the various scams happening today and how we can protect ourselves against these attacks. Implementing cyber security best practices, such as strong passwords, thinking before you click on suspicious links, multi-factor authentication and installing security software is crucial.

#### **Business Meeting**

*Minutes* — Upon motion made and seconded, the minutes of the membership meeting held on March 15, 2022, were approved.

*Financial Reports* — Donna Gantt provided the Treasurer's Report as of December 31, 2022, which reflected an ending balance of \$43,212 for both checking and savings accounts. In addition, expenses incurred to date from the beginning of the year and anticipated expenses following the annual meeting were also reviewed, with an estimated ending balance of \$24,216 as of March 14, 2023. *(See updated financial statement as of 6/21/23 on page 10.)* 

*Membership Report* — Donna Gantt noted that as of 3/1/23, the association has 397 active members. Sixteen new members in 2022 and four new ones in 2023 as of March 14.

**Deceased Members Report** — Donna also reviewed the deceased members report for 2022, followed by a moment of silence in memory of those lost. It was noted that five member deaths occurred in 2022.

*Nominating Committee Report*: Bill Melton, Chair of the Nominating Committee, reported the following nominees for those seats up for election and re-election this year. Upon motion made and seconded, the Nominating Committee's report was approved by the membership, with Rosanna Herren, Bill Melton, Dave Lawrence and Larry Shoffner being elected and Lindsay Harnish and Clement Hathaway being re-elected, all for two-year terms ending in 2025. *(See article on page 3 for a list of the 2023 board and bios for new/re-elected members.)*  **2024 Site Selection** — Marie Stiles, along with committee members Jack Drew and Richard Monson, have worked with Lisa Royster, our meeting planner, to secure the Hilton DeSoto Hotel, located in Savannah, Georgia, on March 4-5th for the 2024 annual meeting. The group rate quoted per night is \$189. The group rate would apply two days after the meeting but a higher rate of \$249 would apply two days prior to the meeting.

*Comments from Board Chair/President* — David Bridges reviewed items discussed and/or approved at yesterday's board meeting:

• **Bylaws** - Approved proposed revised Bylaws for the AgFirst Retiree Association

• Nominating Committee — Approved a Purpose Statement for the AgFirst Retirees Nominating Committee in order to provide guidance to future Nominating Committees in its search for potential candidates to the AgFirst Retiree Association Board of Directors.

• Committee Assignments — The chair made the following committee assignments to research respective issues and provide recommendations, as needed, to the Board for consideration. Members were asked to provide input on any of the issues noted and if they would like to serve on any of the committees, to contact the chair:

1) Membership Expansion/Affiliation with Other Retiree Entities — Rosanna Herren, Chair; Bill Melton, member

2) Procedures for Secretary/Treasurer — Beverly Ratcliff, Chair; Maribeth Corbett, Donna Gantt, members

3) Tax Structure - Donna Gantt, Chair; Bill Melton, member

*4) Review of Goals and Objectives* — Maribeth Corbett, Chair; Beverly Ratcliff, member

• **Door Prizes** — Approved the following door prizes to be drawn at Tuesday night's banquet:

- various AgFirst gifts
- 4 bottles of wine from Silver Coast winery
- 2 one-night hotel stay at the Annual Meeting\*

David thanked everyone who had helped him during his tenure as board chair/president, making his job easier. It was the best of times and the worst of times — COVID, but felt that much was accomplished. In addition, he thanked everyone for making the 2023 annual meeting a success and looked forward to seeing everyone at next year's meeting in Savannah, Georgia. • Recognition — Allyn Lamb recognized David Bridges for all of his commitment and time for the past several years to the AgFirst Retiree Association and thanked him for his service as board chair and president of the association.

With no further business, the meeting was adjourned.

# 6 Tips for Senior Sun Safety

Summer weather is great for relaxing with family and friends. Being outside for pool parties, barbecues, and beach trips are what make summertime so much fun.

Too much outdoor time, however, can lead to problems like sunburn and dehydration in elderly populations who are especially at risk for these hot-weather woes. But by taking a few precautions, problems like sunburn and dehydration in the elderly can be avoided and seniors will be able to get the most out of long summer days.



The best summertime clothing for seniors is lightweight and made out of a breathable fabric such as cotton. Shirts should be long-sleeved, and seniors should wear wide-brimmed hats to protect from the sun.

#### Apply sunscreen early and often.

Sunscreen takes time to work, so don't wait until you're poolside. Try to apply sunscreen about an hour before you head outside, and reapply every two hours. Look for a broad-spectrum sunscreen that protects against both UVA and UVB radiation.

#### Drink plenty of fluids.

Seniors are less likely to feel thirsty, and dehydration can come on quickly and be dangerous. Try to drink between 6 and 8 glasses of water a day, and increase your intake if you're doing any kind of physical activity, or if the weather is particularly hot.

# Stay indoors at the hottest hours.

The sun is most intense during the middle of the day. If you're a tennis player or gardener, it's best to keep these activities to the early morning or evening, when the weather is cooler. Try to stay indoors when the sun is at its peak.



WARNING: Knowing the signs of heat stroke can save a senior's life. A flushed face, high body temperature, headache, nausea, rapid pulse, dizziness and lack of sweating despite the heat are signs that immediate action should be taken. Drinking water, a cool ice pack to the back of the neck, and removal of the sun is a must at the earliest signs of these symptoms.

# Wear eye protection.

Seniors have very sensitive eyes. Wearing sunglasses can help reduce the cumulative damage that causes eye problems such as cataracts and age-related macular degeneration in seniors. Wrap-around styles that protect from both UVA and UVB radiation are best.

# Check your medications.

Some medications can cause increased sensitivity to the sun. Look over your medications, and talk to your doctor about any concerns or questions you have.
