Retiree Association Objectives

This past year, the Board continued its review of various documentation regarding the Retirees Association to ensure each accurately reflects and simplifies the current purpose and mechanisms of the Association. In this regard, the Board approved the following revised Objectives of the Retirees Association:

#1 – Social - Provide opportunities for retirees to gather together for renewing friendships or making new friends

#2 – Educational

- Provide information on matters of mutual interest to the membership
- Publication of a newsletter to the membership on upcoming events, items of interest, etc.
- Provide an appropriate forum for members to exchange ideas and suggestions

#3 – Advocacy

- Promote membership in the AgFirst Retiree Association
- Promote Farm Credit and support legislative or other activities which would benefit Farm Credit and its members
- Enlist members to support the AgFirst Retiree Association's objectives and goals.

AgFirst Farm Credit Retiree Association Membership Meeting March 5, 2024

A meeting of the membership of the AgFirst Farm Credit Retirees Association was held on Tuesday, March 5, 2024 at the DeSoto Hotel in Savannah, Georgia.

President Bill Melton welcomed everyone to the meeting. A quorum was determined, and the meeting was called to order.

Welcome – On behalf of AgSouth Farm Credit, Van McCall, AgSouth retiree, welcomed everyone to the AgSouth territory.

Invocation – With the use of Legos, Van McCall provided an inspirational outlook as to how we migrate to different seasons of our lives.

AgFirst/District/System Update – Tim Amerson provided an update on the Farm Credit System and the AgFirst District. Financially, the System is in a very strong position and is well capitalized. The System has approximately \$398 billion in loans; \$508 billion in assets; net income last year of \$7.4 billion; and healthy credit quality. There are currently 4 System banks and 56 associations, with the AgFirst District representing about 10% of the System's volume.

The AgFirst District association count as of January 1 is 16, ranging in size from \$6.8 billion in assets to \$181 million. The District had about \$600 million in net income last year, which is a decrease from the previous year.

The Bank's net income last year was about \$265 million, which was also lower than the previous year. The Bank is performing in accordance with established plans; however, income for the next couple of years is expected to be lower due to interest rates and technology projects. While the District had a growth rate of 6.95% in 2023, the District is not growing at the rate as the rest of the Farm Credit System. He noted that some associations are growing more than others.

This past year has been one of the hardest and most challenging for employees due to the implementation of the various new IT systems. This year will continue to be a struggle with not only the learning curve but also addressing issues associated with implementation of the new systems and updating other interfaces. However, these new systems will put the AgFirst District in a strong, solid position. Tim noted that the collaboration between the Bank and the associations have been strong during this process despite the issues associated with implementation of the new IT systems.

Before closing, Tim indicated that the retirement fund is 98% funded and even though there is volatility in the market these days, the retirement fund continues to be very stable.

Benefits Overview – Following a brief overview of how to make update/changes to your benefits plans, Becky Infinger, the Bank's Health & Benefits Supervisor, took questions from the audience. After responding to various questions on benefits, attendees requested that the Bank increase its communications/notifications to retirees regarding changes to their benefits as well as any other matters that could have an impact (i.e. United Healthcare and Prisma Health unable to reach an agreement, thus possibly impacting out of pocket costs, etc.).

Minutes – Upon motion made and seconded, the minutes of the membership meeting held on March 14, 2023, were approved.

Financial Reports – Bill Melton, in the absence of Donna Gantt, Treasurer, provided the Treasurer's Report as of December 31, 2023, which reflected an ending balance of \$33,277 for both checking and savings accounts.

Bill Melton noted that he had recently met with the AgFirst Presidents Planning Council and they have agreed to increase their annual contribution to the Retirees Association beginning with next year.

Bill asked that as each member visits with their association that they thank them for their continued support of the Retirees Association.

Membership Report – Maribeth Corbett noted that as of 3/1/24, the Association has approximately 400 active members. Thirteen new members were added in 2023 and so far for 2024, nine new members have joined. She encouraged all members to become an advocate for the Retirees Association and get the word out about the Association. Applications for membership should be included in each retirees' informational packet from the Bank but can also be found on our website – agfirstretireeassociation.org.

Deceased Members Report – Maribeth Corbett noted that the deceased members report for 2023 had been received from the Bank, which indicated that there were eleven member deaths occurring in 2023. A list of these members was provided during the meeting.

2024 Nominating Committee Report – Larry Shoffner, Chair of the Nominating Committee, reported the nominees for those seats up for (re)election this year. Upon motion made and seconded, the Nominating Committee's report was approved by the membership, with Richard Monson and Rob Teston being elected and Allyn Lamb, Frank Whitaker, Janet Reynolds and Maribeth Corbett being re-elected, all for a two-year term ending in 2026. (See separate article for a list of the 2024 Board and bios for new/re-elected members.)

2025 Site Selection – Darrell Curtis and Clement Hathaway, along with Lisa Royster, our meeting coordinator, presented to the Board potential sites for our 2025 meeting. Based on the recommendations of the committee, the Board selected the Omni Hotel in Charlottesville, Virginia for the 2025 AgFirst Retirees Association Annual Meeting on April 28-29, 2025. The group rate quoted per night would be \$189.

Comments from Board Chair/President – Bill Melton reviewed items discussed and/or approved at yesterday's board meeting.

Amended Bylaws – Approved a proposed revision to the Bylaws for the AgFirst Retiree Association that expanded qualifications of members to allow for any former employee within the Farm Credit System to also be eligible to be considered for membership.

Increased Information to Members – Discussions were also held as to the need to provide members with more useful information and for the Retirees Association to become a knowledge resource. At this stage in life, retirees are looking for more information on what benefits are available for them and how to get them; who to contact for help in times of need or just letting others know who might need some special assistance; and just overall knowledge about those items that they need to be aware of. It was agreed that we need to look at ways to include this information on our website, Facebook page and newsletters. Bill encouraged members to let us know if there is something they would like to be posted.

Revised Objectives – Approved revised objectives for the Retirees Association, which have been simplified to reflect three main objectives: Social, Educational and Advocacy.

Recognition – Bill thanked everyone who had helped pull this meeting together, particularly Lisa Royster, our meeting coordinator, for all the hard work done to make this meeting a success. He also thanked everyone for attending and look forward to seeing everyone at next year's meeting in Charlottesville, Virginia.

With no further business, the meeting was adjourned.
